
**Engagement of Village Level Entrepreneur (VLE) on contract in Jagdala Gram Panchayat under Bamangola Development Block**

**Date of Notification: 21.12.2021**

In pursuance of the Order No. 144(18)/Comp/Estt/WBSRDA(BRGF)/02/08 dated 12.06.2008 of the Principal Secretary to the Government of West Bengal and Memo No. 1860 – RD/O/NREGA/18S-03/10 dated 31.03.2017 of the Commissioner, Panchayats & Rural Development applications are hereby invited from eligible candidates for the engagement to the post of 1 (one) no. of Village Level Entrepreneur (VLE) under MGNREGS, West Bengal on **purely contract basis** for 1 (one) year to be posted in **Jagdala Gram Panchayat** under the jurisdiction of Bamangola Development Block. The engagement may also be terminated by appropriate authority for unsatisfactory service, misconduct etc. of the incumbent concerned. It is hereby notified to all concerned and eligible candidates under the jurisdiction of Bamangola Development Block that the contractual post of Village Level Entrepreneur (VLE) will be engaged in **Jagdala Gram Panchayat** as per the following norms and condition laid down below:-

1. **Educational Qualification:** Minimum educational qualification for the post of Village Level Entrepreneur (VLE) is passed in Madhyamik examination. The marks will be based on the recognized mark sheet issued by the concerned Board / Council. The verification of the certificate issued by authorities of other state will continue to be subjected to verification by issuing authority. The candidate must have at least six months course on Computer application from any recognized institute
2. **Age:** Candidates should preferable above or equal to 18 (eighteen) and below or equal to 35 (thirty five) years of age as on 01.01.2022. The upper age limit is relaxable up to 5 (five) years for SC/ST and 3 (three) years for OBC as per Government order.
3. **Residence:** The candidates must be local resident and elector of the Bamangola Development Block area.
4. **Remuneration:** The Village Level Entrepreneur (VLE) will be paid a consolidated monthly remuneration of Rs. 10,300/- (Rupees Ten thousand three hundred) only and the period of contract will be one year. After the period of one year contract, the renewal of the contract for one more year may be allowed subject to satisfactory service rendered by the Village Level Entrepreneur (VLE) by the undersigned.
5. **Method of Selection:** Village Level Entrepreneur (VLE) will be selected on computer test and interview.
6. **Documents to be submitted:** The eligible candidates as per mentioned criteria will apply to the undersigned on or before 07.01.2022 within 5:00 PM at prescribed format either in writing or in typing. Other than the 'Application Form', the following documents to be submitted with **self attested:**
  - i) 'Application Form' in prescribed format.
  - ii) Age Proof Document (Madhyamik Admit Card / Birth Certificate). In the case of age relaxation, relevant certificate signed by the specified authority.
  - iii) Document in respect in Educational Qualification (Madhyamik Examination Marksheet and Certificate only).
  - iv) Document in respect of Computer Certificate.
  - v) Proof of Residence (EPIC)

7. **Method of Apply:** The above documents are to be submitted in a sealed envelope in the drop box at MGNREGA Cell on any working days between 11:00 AM to 5:00 PM or through post / courier within 07.01.2022 at 5:00 PM sharp.
8. **Verification of Testimonials:** The selected candidate will be called for documents verification with all original testimonials. If any candidate fails to produce his / her original testimonials at the time of verification then his / her candidature will be cancelled. The authority reserves every right to change / medication / rectification any or entire of the schedule / criteria or cancel this notice anytime hereafter upon concurrence from higher authority.
9. Others terms and condition for the said post will apply as per Government norms.


