- 1) The candidates may be retired Government Stenographer or fresh candidates.
- 2) The candidate should not be more than sixty-four years of age as on 31/03/2025.
- 3) The selected retired persons will get consolidated contractual remuneration of Rs. 15,000/- (Rupees fifteen thousand) per month only and freshly engaged contractual stenographers will get Rs. 25,000/- per month only.
- 4) The appointment will provisionally be made for 1 (one) year or till filling up of the vacancies on regular basis, whichever is earlier.
- 5) Candidates thus selected will be on whole time basis and holding of any other engagement will not be permitted during office hours.
- 6) No request for change of place of posting in this regard will be entertained.
- 7) The candidates have to submit self-attested relevant documents along with application subject to verification of original documents at the time of Interview cum Speed Type Test at the concerned offices. Admission to the Interview-cum-Test is purely provisional subject to determination of eligibility in terms of the advertisement.
