### **Terms & Conditions:**

1. The above-mentioned engagement shall be purely on temporary basis for six months from the date of joining in the post subject to extension, if required as per decision of the authority. This engagement will not be treated as employment /re-employment/contractual employment.
2. Monthly consolidated remuneration for the posts shall be payable subject to satisfactory service during the month which is to be certified by the head of the respective section. Further, no increment/ allowance/ Bonus/ Ex-gratia except the above-mentioned amount shall be payable.
3. Engaged individual shall have to discharge the duties and responsibilities as and when desired or assigned by the authority.
4. No earned leave is admissible. Casual leave of 7 days shall be permissible over the course of six months.
5. The engaged individual will have the right to leave his temporary engagement after giving 15 days prior notice in writing. Similarly, the engagement is terminable, at the discretion of the authority, at any point of time, by giving him 15 days prior notice in writing.
6. The engagement shall be terminable without any prior notice from the authority in the event of the involvement of the individual in any malpractices pertaining to his services under this authority.
